2. Paragraph 5A: Option Fee Per new contract, option, and EM are to be delivered to the title company. Seller prefers \$60 per day for the OP Fee and a max of 5 days for the option period.

3. Paragraph 5A: For Earnest Money, the Seller prefers Earnest Money of at least 1% of the contract sales price.

4. Paragraph 5B: Termination Option- Seller allows max 7days for termination

5. Paragraph 6C- SURVEY

a. Allow 15 days before closing for the seller to furnish you with the final survey. We must construct the driveway first before calling for the survey.

6. Paragraph 6D-Objection: Allow max 5 days for objection

7. COMPLETION Paragraph 7C: The property will be substantially completed not later than 12/12/2025, and ready for occupancy not later than 12/30/2025.

8. Insulation Information

The exterior wall is insulated with rolled-in fiberglass insulation with a thickness of 3,5 inches which yield R-value of R13.

The ceiling in the improved area is insulated with blown-in fiberglass insulation with a thickness of 12.5 inches, which yield R-value of R30.
