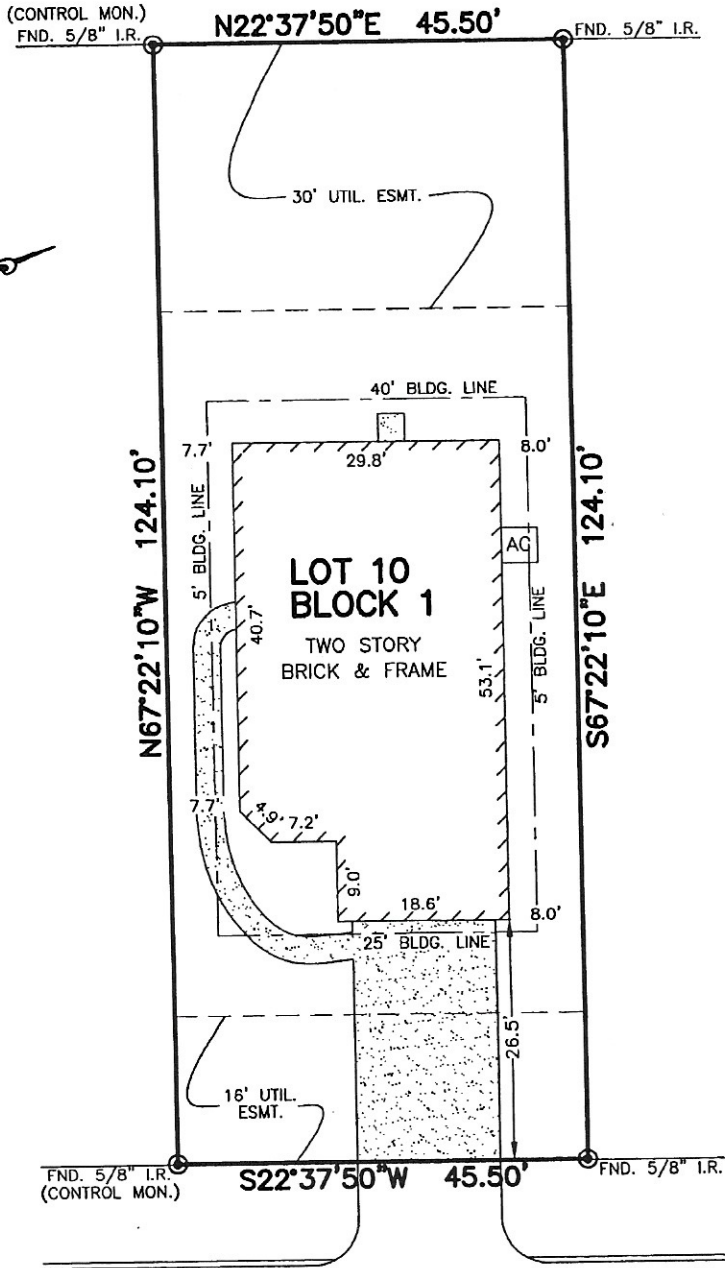


PARTIAL REPLAT OF GLENEAGLES SEC. 1 & 2
