


## NOTES

**METES AND BOUNDS DESCRIPTION

- THENCE:** N 19°09'40" W, for a distance of 939.51 feet to a calculated corner on the northern boundary line of said 22.477 and southern boundary line of a tract conveyed to Barbara D.
