# NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in the Pecan Grove Municipal Utility District (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.625 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters, approved by the voters are:

\$32,000,000 for water facilities;  
\$24,300,000 for Drainage and Reclamation; and  
\$33,600,000 for water, sanitary sewer and drainage facilities.

The aggregate initial principal amounts of all such bonds issued are:

\$32,000,000 for water facilities;  
\$24,300,000 for drainage and reclamation; and  
\$14,985,000 for water, sanitary sewer and drainage.

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Richmond. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a District that is annexed by the municipality is dissolved.

The District has entered into a strategic partnership agreement with the City of Richmond. This agreement may address the timeframe, process, and procedures for the municipal annexation of the area of the District located in the municipality's extraterritorial jurisdiction.

The purpose of the District is to provide water and sewer, drainage and flood control, park and recreational and fire-fighting facilities and services. The cost of District facilities is not included in the purchase price of your property.
