

# NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in the Bay Colony West Municipal Utility District (the “District”) and may be subject to district taxes or assessments. The current rate of the District property tax is \$0.86 on each \$100 of assessed valuation. The District may impose assessments and issue bonds and impose an assessment in payment of such bonds. The total amount of bonds payable wholly or partly from property taxes, excluding refunding bonds and excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, that are separately approved by the voters are: (i) \$44,000,000 for water, sewer, and drainage facilities; and (ii) \$2,800,000 for parks and recreational facilities. The aggregate initial principal amounts of all such bonds issued are (i) \$37,905,000 for water, sewer, and drainage facilities; and (ii) \$2,800,000 for parks and recreational facilities.

The District is located wholly or in part in the jurisdiction of the City of League City. Texas law governs the ability of a municipality to annex property in the municipality’s jurisdiction and whether a district that is annexed by the municipality is dissolved. The purpose of the District is to provide water, sewer, and drainage facilities and services. The cost of District facilities is not included in the purchase price of your property.
