

**AMENDED DISTRICT INFORMATION FORM**

In compliance with Section 49.455, Texas Water Code, as amended, the undersigned members of the Board of Directors of Meadowhill Regional Municipal Utility District (the "District") hereby affirm as of the date hereinafter set out that the following information is correct and accurate:

1. The name of the District is Meadowhill Regional Municipal Utility District.
2. The most recent rate of taxes established by the District on property located in the District is set forth in the form of Notice to Purchasers contained in Exhibit "A", attached hereto and made a part hereof for all purposes, as same may hereafter be from time to time amended.
3. The total amount of bonds that have been approved by the voters and which may be issued by the District (excluding refunding bonds and any bonds or portion of bonds payable solely from revenues received or expected to be received pursuant to a contract with a governmental entity) is \$69,265,000.00.
4. The aggregate initial principal amount of all bonds of the District payable in whole or in part from taxes (excluding refunding bonds and any bonds or portion of bonds payable solely from revenues received or expected to be received pursuant to a contract with a governmental entity) that have been previously issued is \$48,250,000.
5. If a standby fee is imposed by the District, the amount of the standby fee is set forth in the form of Notice to Purchasers contained in Exhibit "A", attached hereto and made a part hereof for all purposes, as same may hereafter be from time to time amended.
6. The date on which the District was created is June 4, 1971.
7. The functions performed or to be performed by the District are as follows:
  - (a) Supply water for municipal uses, domestic uses, power and commercial purposes and all other beneficial uses or controls;
  - (b) Collect, transport, process, dispose of and control all domestic, industrial or communal wastes, whether in fluid, solid or composite state;
  - (c) Gather, conduct, divert and control local storm water or other local harmful excesses of water in the District;
  - (d) Irrigate the land in the District;
  - (e) Alter land elevation in the District where it is needed;
  - (f) Navigate coastal and inland waters of the District; and
  - (g) Provide parks and recreational facilities for the inhabitants in the District.

We, the undersigned, being the duly chosen members of Meadowhill Regional Municipal Utility District, each for himself, affirm and declare that the above is true and correct to the best of our knowledge and belief.





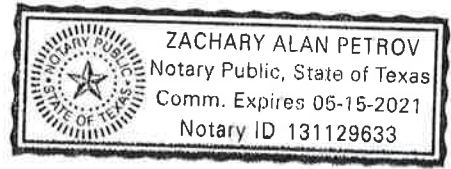

The real property that you are about to purchase is located in **MEADOWHILL REGIONAL MUNICIPAL UTILITY DISTRICT** (the "District") and may be subject to district taxes or assessments. The district may, subject to voter approval, impose taxes and issue bonds. The district may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax for year 2024 is \$0.551 on each \$100 of assessed valuation, comprised of \$0.24 per \$100 assessed valuation for debt service purposes and \$0.311 per \$100 assessed valuation for operation and maintenance purposes.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters, approved by the voters are:

\$69,265,000 for water, sewer, and drainage facilities

The aggregate initial principal of all such bonds issues are:

\$48,250,000 for water, sewer, and drainage facilities

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.

The purpose of the District is to provide water, sewer, drainage, flood control, parks and recreational, and flood control facilities and services. The cost of district facilities is not included in the purchase price of your property.
