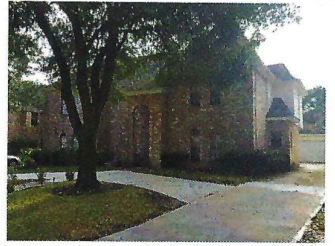




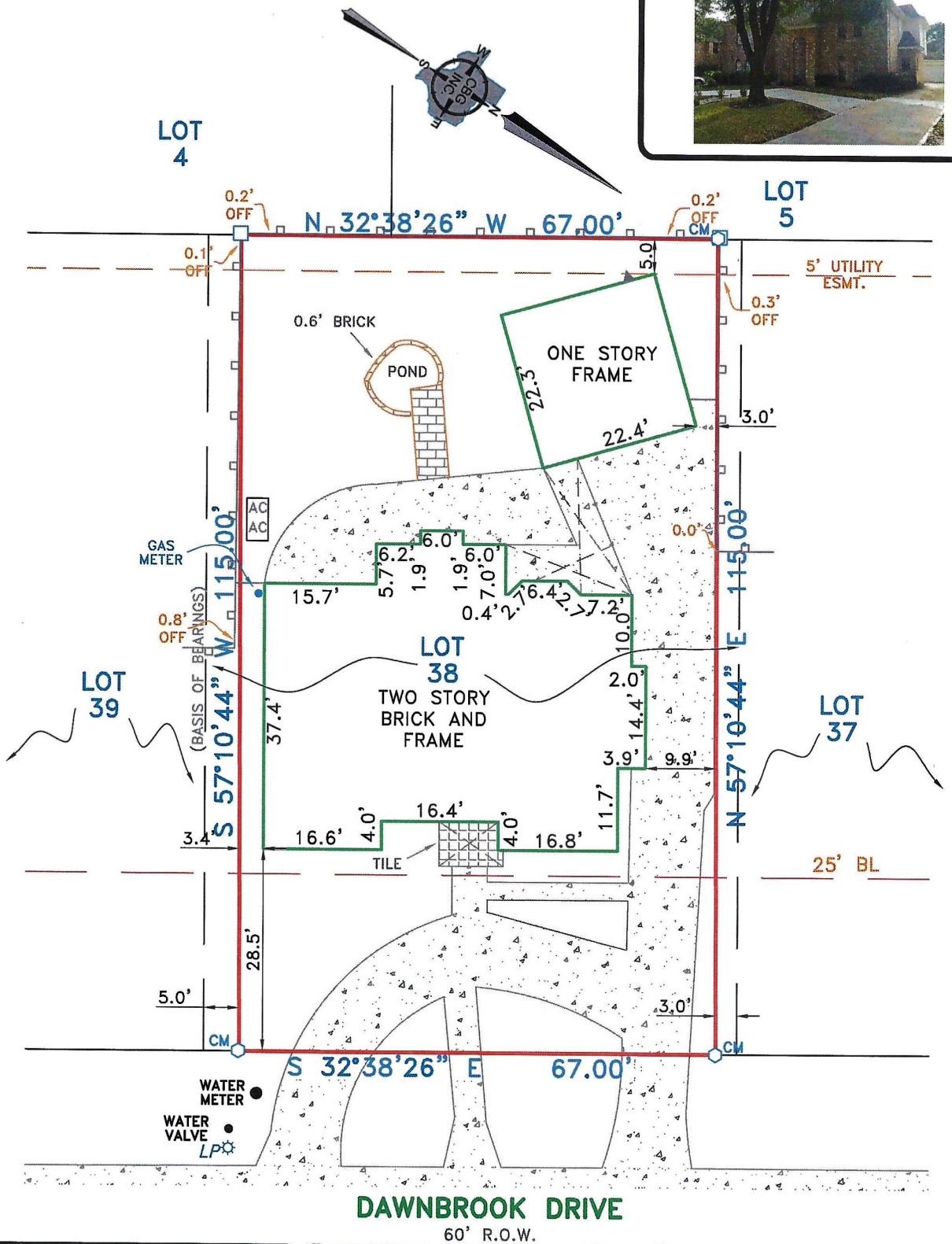
# 15311 Dawnbrook Drive
