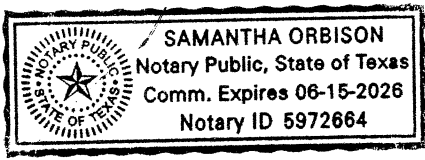

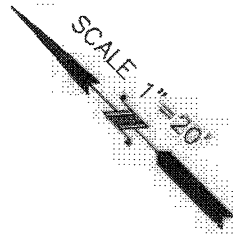

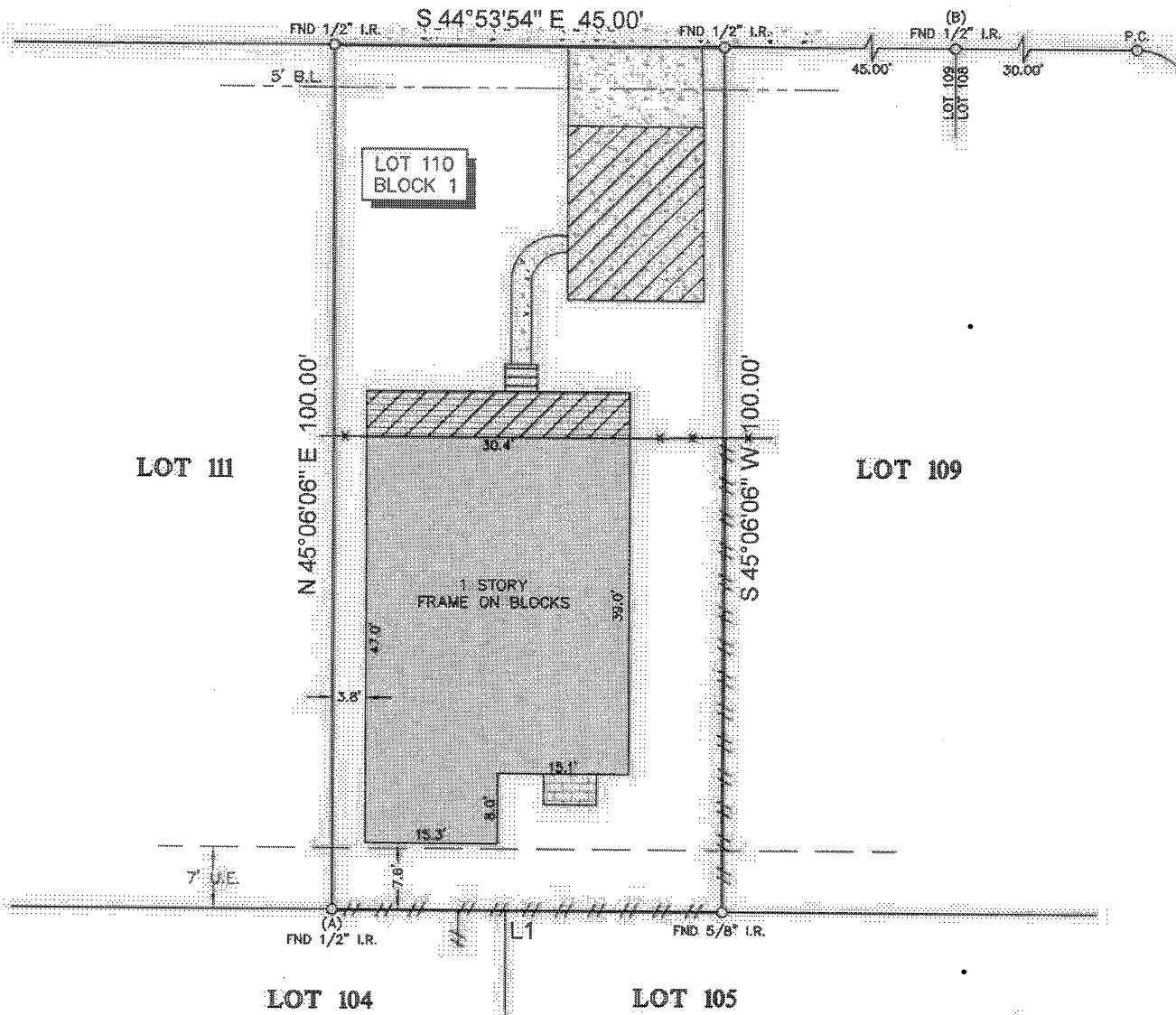

(28' P.A.E.)



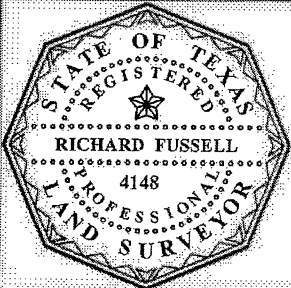
