- 1) TEAR OFF EXISITNG COMPOSITION SHINGLES AND HAUL AWAY.
- 2) REPLACE ANY BAD DECKING AS NEEDED AT NO ADDITIONAL COST.
- 3) REPLACE APPROX. 40 FEET OF 1x6 CEDAR FASCIA AND 40 FEET 1x2 CEDAR TRIM.
- 4) INSTALL NEW #15 FELT OVER DECKING AND NEW 2"x2" GALVANIZED EVE METAL AROUND PERIMETER OF ROOF WITH COLOR TO BE BROWN TO MATCH TRIM.
- 5) REPLACE ALL ROOF VENT FLASHINGS AND PAINT TO MATCH TRIM.
- 6) REMOVE EXISTING WIND TURBINE AND INSTALL APPROX. 48 FEET OF COBRA-3 RIDGE VENT
- 7) INSTALL NEW GAF TIMBERLINE HIGH DEFINITION ARCHITECTURAL SHINGLES WITH COLOR TO BE "SHAKEWOOD". NEW SHINBGLES WILL BE HAND NAILED USING 6 (SIX) NAILS PER SHINGLE.
- 8) YARD WILL BE CLEANED OF NAILS USING MAGNETIC SWEEPER.
- 9) ALL JOB RELATED DEBRIS WILL BE PICKED UP AND HAULED AWAY.
