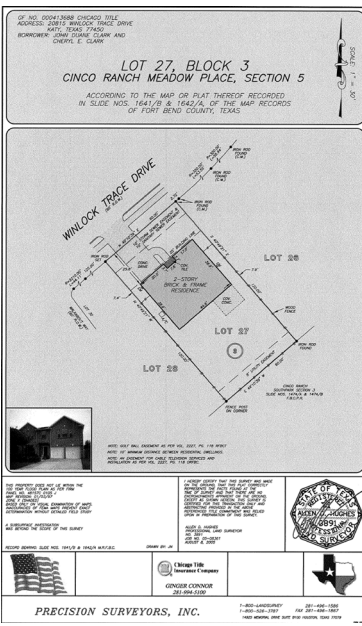

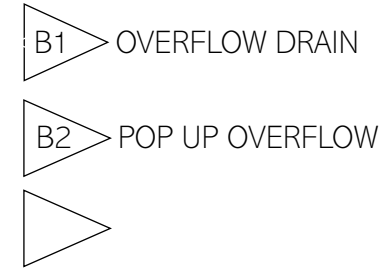

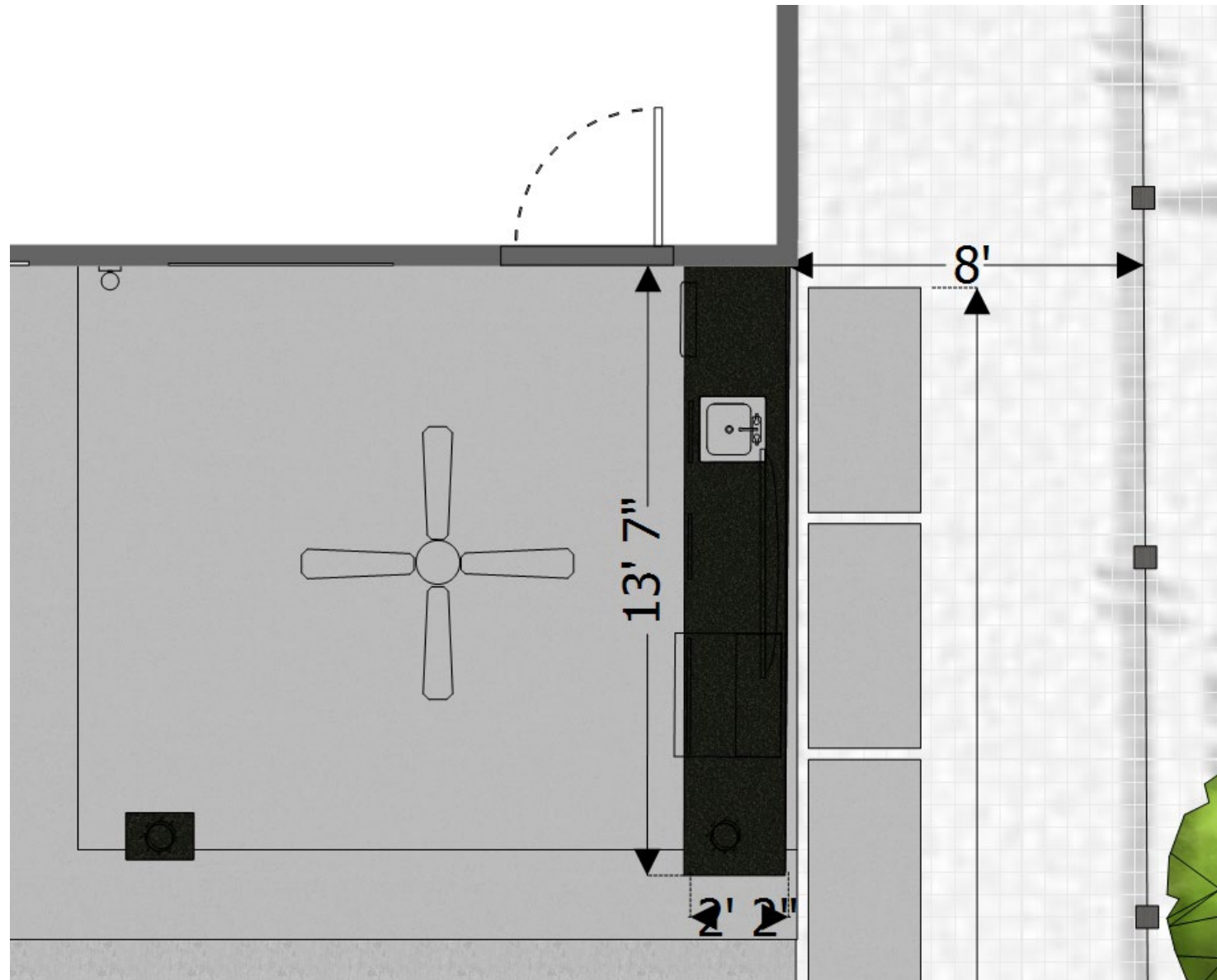
SITE DRAIN OVERFLOW PLAN

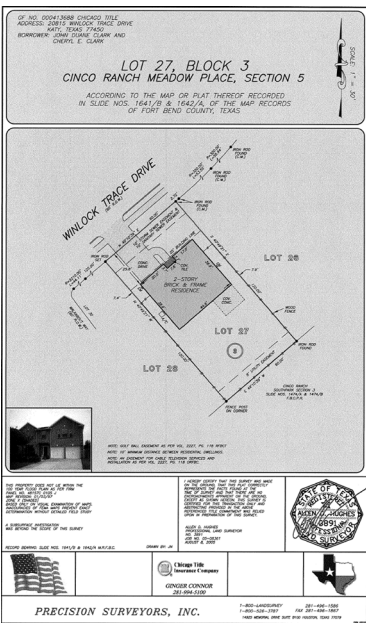
