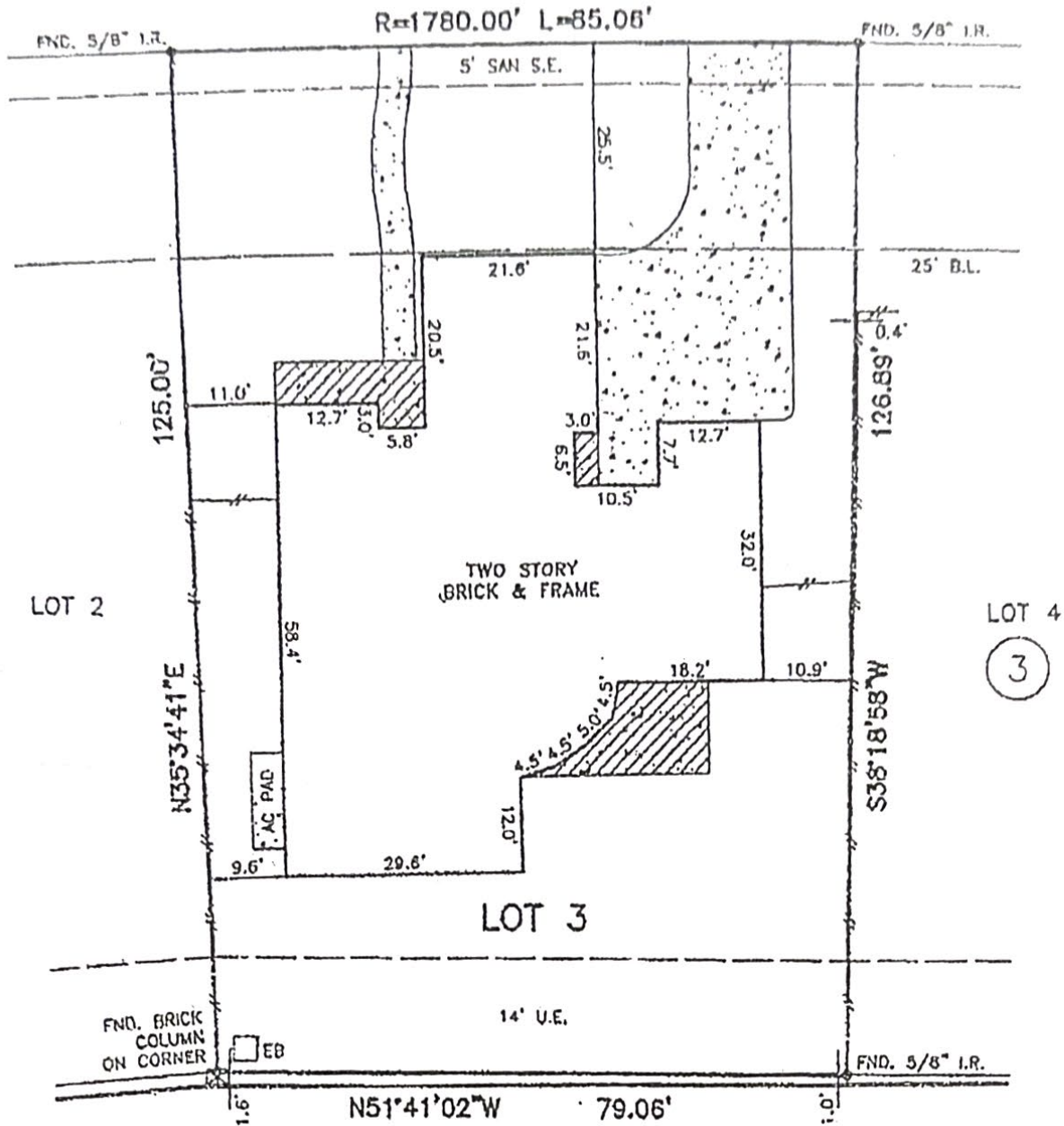


CLEARWATER CROSSING
