The current rate of the district property tax is \$0.70502 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters and excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by voters are:

\$90,559,688 for water, sewer, and drainage facilities; and
\$0 for road facilities; and
\$0 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:
\$65,230,000 for water, sewer, and drainage facilities; and
\$0 for road facilities; and
\$0 for parks and recreational facilities.

The district is located wholly or partly in the extraterritorial jurisdiction of the City of Missouri City. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.

The purpose of the district is to provide water, sewer, drainage, flood control, or other types of facilities and services. The cost of district facilities is not included in the purchase price of your property.

The current rate of the District property tax is \$0.535 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, and excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity, approved by the voters are:

\$22,550,000 for water, sewer, and drainage facilities;

\$9,100,000 for parks and recreational facilities; and

\$9,120,000 for refunding bonds.

The aggregate initial principal amounts of all such bonds issued are:

\$17,700,000 for water, sewer, and drainage facilities; and

\$4,815,000 for parks and recreational facilities.

The District is located wholly or partly within the corporate boundaries of the City of Sugar Land. The municipality and the District overlap, but may not provide duplicate services or improvements. Property located in the municipality and the District is subject to taxation by the municipality and the District.
