(Ceilings) Garage ceiling drywall was opened to run electrical wiring for an EV/Tesla charger and later patched. Patch/finish work is visibly imperfect. To Seller's knowledge, this area is not the result of water intrusion.

(Doors) Some interior doors may stick or rub at times. Seller is not aware of a specific structural cause.

(Electrical System) Seller is aware of a prior issue in the electrical panel involving the dryer breaker/circuit tripping. Electrician relocated the dryer circuit/breaker to another panel slot and labeled the prior slot/breaker "Do Not Use." Seller is not aware of current dryer circuit issues since the relocation. Buyer should verify electrical panel condition during inspection.

(Floors) There is a 9 inch diameter rust spot on the back patio flooring due to a flower pot which rusted out. Seller has no other knowledge as to any other cause related to this issue.

(Windows) One window in the primary bedroom does not close tightly enough for the lock to engage. Adjacent windows appear to operate normally. This condition has existed since Seller purchased the home. Seller is not aware of any related water intrusion.

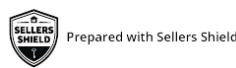

Sellers received settlement proceeds from a disputed pool construction claim involving the pool builder. The dispute included pool project construction issues, including paver/decking and easement-related concerns, front yard/irrigation restoration, project delay, and contract-related claims. Some items were repaired/restored; settlement proceeds were not allocated dollar-for-dollar to specific repairs, and not all disputed items resulted in physical repairs. Sellers believe the paver decking is non-permanent and not a covenant violation. The settlement was a compromise of disputed claims and was not an admission of liability by the builder.
