Requirements (Please make sure you read everything below **carefully** because once an application fee is paid, it becomes **NON-REFUNDABLE**):

- ☐ Must make 3x the rent. Income must be verifiable. We send a verification link to you to verify employment/income. The name on the request will be Total Real Estate Services and you will need to link your bank account that your employer deposits the money into.
- ☐ Must have at least 600 credit score and recent credit lines must be paid on time. Even if your credit is 600, it is still on a case-by-case basis. No open bankruptcies or judgments allowed.
- ☐ Acceptable Criminal Background (We will run a background check)
- ☐ Must have PERFECT rental history. No broken leases, evictions, slow pay, or violations.
- ☐ No aggressive breed pets. This includes pets mixed with aggressive breeds (we can decline a dog at our discretion if we think it is mixed with an aggressive breed). Other breeds are still on a case-by-case basis.

Documents needed from each person over 18 years of age:

- ☐ Please fill out the application online at <https://honeywoodrealty.managebuilding.com/Resident/rental-application/new> and attach all items below in the application online at this link provided.
- ☐ Color copy of Driver's license and Social Security Card
- ☐ Picture of all pets (if applicable) **All applicants, regardless of if you have a pet or not, will be required to create a profile at honeywoodrealty.petscreening.com. It is free for Service dogs, or non-pet profiles. Make sure so fill the entire form out as poor fido scores will trigger an additional \$25 pet rent. There is a \$30 charge (per pet) for creating a pet screening account. If they are unable to legitimize the Service dog letter from your doctor, you will be required to pay for this service. It is a small \$25-\$30 yearly fee. <https://honeywoodrealty.petscreening.com>. Please note, ESA dogs will still have to pay pet deposits per the new US Department of HUD Guidelines.**
- ☐ 2 months of check stubs. If self-employed, we need 2 years of tax returns. If using tax returns, use the net income after deductions to determine if your client makes 3x the rent. We send a verification link to you to verify employment/income. The name on the request will be Total Real Estate Services and you will need to link your bank account that your employer deposits the money into. **Bank statements are not acceptable.**
- ☐ \$50/person app fees (non-refundable) paid at the end of the online application. **We will not begin running any applications without receipt of all application fees. Fees are paid online at the end of the application portal.**
- ☐ AGENTS- THIS DOCUMENT MUST BE SIGNED BY EACH PROSPECTIVE TENANT AND YOU AS THEIR AGENT AND SENT TO LAIN@HONEYWOODREALTY.COM TO REGISTER YOUR CLIENT(S).
